



Investors Dump Industrial Goods Stocks, Others as ASI Retreats by 0.33%; Naira Edges the Dollar to N795.41.....

The local bourse closed southward at the commencement of the week, retreating from the previous weeks' gain by 0.33% with the benchmark index crashing to 70,612.81 points, as investors dump JAPAU LGOLD, BUACEMENT, VERITASKAP, UNIVINSURE, and CHAMS whose share prices shed 9.09%, 7.76%, 7.41%, 4.00% and 3.85% due to waning sentiments. Resultantly, the overall market cap decreased by 0.33% to N38.8 trillion, although the market exhibited more advancing stocks (26) than declining ones (18). Performance was bearish across sub-sector gauges tracked as three out of the five sub-sector gauges tracked close in the red zone; the Insurance, Consumer Goods, and Industrial Goods indexes declined by 0.09%, 0.02% and 3.27%, respectively. In contrast, the Banking sector increased by 0.38%, while the Oil & Gas index held steady compared to the previous session. Despite the bearish sentiment in the market, trading activity showed further improvement with total deals and value increasing by 20.96% and 39.35% to 7,630 trades valued at N7.75 billion; although the total traded volume for the day plummeted by 14.79% to 474.39 million units. FIDELITYBK was the most traded security in terms of volume with 94.05 million units worth N858.55 million traded, while MTNN was the most traded in terms of value, amounting to N2.23 billion.







Money Market

In the money market, NIBOR closed in the mix at the end of the trading session on Monday. The Overnight and 6-month NIBOR advanced by 0.37% and 0.17%, while the 1-month and 3-month NIBOR declined by 2.92% and 0.12%. Key money market rates, including the open repo rate (OPR) and the overnight lending rate (OVN) increased by 0.34% and 0.32% to 16.92% and 17.90% respectively.

In the Nigerian Interbank Treasury Bills market, the Nigerian Interbank Treasury Bills True Yield (NITTY) moderated on Monday for maturity of the tenor buckets tracked. Additionally, the average secondary market yield on Nigerian Treasury Bills was bullish, slightly decreasing by 2bps to 13.35%.

Bond Market

The secondary market for FGN Bonds remained quiet on Monday as the average yield across the short, mid and long of the curve stayed muted at 15.67% from the prior close.

In Nigeria's sovereign Eurobonds market, activity level was dominantly in the bullish region as positive sentiments pervaded the movement in yields. As a result, the average yield in the market inched lower by 3bps to close at 11.46% due to bullish buy interest.

Foreign Exchange Market

In the foreign exchange market, the Naira depreciated at the Nigerian Autonomous Foreign Exchange Market (NAFEM) window, closing at N795.41 per dollar. Consequently, in the parallel market, the Naira also depreciated by 1.79% to N1,140 per dollar.
