




## Investors Score Big on Tuesday as Industrial, Banking Stocks Drive Gains; Over Night NIBOR Declines on System Liquidity Ease.....

The local bourse advanced by 0.32% to 70,840.72 points at the close of Tuesday's trading session, and as a result the year-to-date gain climbed to 38.2%. Notably, the bulls (35) outnumbered the bears (16) as investors hunted for bargains, particularly in small and mid-cap stocks. Share prices of NNFM, MECURE, CILEASING, LIVINGTRUST and MEYER expanded by 10.00%, 9.98%, 9.97%, 9.96% and 9.96%, respectively. The Industrial Goods sector was investors' toast for the day, as evidenced by a 1.39% increase in its index. Additionally, the NGX Banking and NGX Insurance indexes rose by 0.69% and 0.23%. On the flipside, the NGX Consumer Goods index declined by 0.11% while the Oil/Gas sector had a lull performance. Market activity dwindled with total deals, volume and value decreasing by 14.38%, 30.98% and 56.54% to 6,533 trades, 327 million units and N3.37 billion respectively. FTNCOCOA was the most traded security in terms of volume with 44.70 million units worth N82.77 million traded, changing hands in 400 deals.



## Money Market

In the money market, NIBOR closed in the mix at the end of the trading session on Tuesday. The Overnight and 6-month NIBOR declined by 0.37% and 0.31%, while the 1-month and 3-month NIBOR advanced by 3.44% and 0.12%. Key money market rates, including the open repo rate (OPR) decreased by 0.09% to 16.83%, while the overnight lending rate (OVN) increased by 0.02% to 17.92%.

In the Nigerian Interbank Treasury Bills market, the Nigerian Interbank Treasury Bills True Yield (NITTY) moderated for maturity of the tenor buckets tracked. Additionally, the average secondary market yield on Nigerian Treasury Bills was mildly bullish, dropping by 1bp to settle at 13.34% at the close of the trading session.

## Bond Market

In the secondary market for FGN Bonds, trading on Tuesday exhibited bearish results. The average yield increased by 7 basis points (bps) to reach 15.74%. This increase was primarily driven by yield expansion of 87bps observed in the JUN-53 FGN paper.

In Nigeria's sovereign Eurobonds market, there was a negative level of activity. Sell sentiment was evident across the short, mid, and long ends of the yield curve, leading to an increase in the average yield by 9bps to settle at 11.55% on Tuesday.

## Foreign Exchange Market

In the foreign exchange market, the Naira depreciated at the Nigerian Autonomous Foreign Exchange Market (NAFEM) window, closing at N850.22 per dollar. Consequently, in the parallel market, the Naira also depreciated by 0.44% to N1,145 per dollar.

## Global Commodity Market

At 3:30 p.m. GMT+1 on Tuesday. Brent crude increased by 1.19% to \$83.5 per barrel, while the West Texas Intermediate (WTI) crude oil also rose by 1.25% to \$79.24 per barrel.
