




ASI Climbs 0.17% to New High as Window Dressing Sustains Momentum; Naira Crashes Across FX Markets

The bulls gained dominance on the stock exchange at the close of Mondays' session, increasing by 0.17% to 71,353.81 points, thus the market exhibited more gainers (32) than losers (20). Notwithstanding, the market cap of listed equities tanked by 0.34% N39.04 trillion, due to the exit of UNION BANK from the stock exchange. Share prices of FBNH, JOHNNHOLT, TANTALIZER, MULTIVERSE and SUNUASSUR expanded by 10.00%, 10.00%, 10.00%, 9.98% and 9.73%, respectively. Performance for most sub-sector gauges tracked was quite bullish: NGX Banking, NGX Insurance and NGX Industrial Goods indices advanced by 1.72%, 0.01% and 0.01%, respectively. In contrast, the Consumer Goods sector faced a decline of 0.99% while the Oil/Gas sector held steady from the previous session. Trading activity saw further improvement as the total deals, volume and value surged by 34.81%, 28.12% and 39.21% to 9,267 trades, 746.67 million units, valued at N5.95 billion, respectively. At the close of the trading session, UNIVINSURE emerged as the most actively traded security, with a total volume of 161 million units valued at N46.83 million, while ACCESSCORP was the most traded in terms of value, amounting to N1.47 billion.





Money Market

In the money market, NIBOR rates moved largely upward across all maturity gauges, despite the overnight NIBOR retreating by 3.17% to reach 21.08%. This southward movement in the Overnight NIBOR comes as the level of system liquidity eased, following expectations of a N907 billion FAAC inflow. Key money market rates, including the open repo rate (OPR) and overnight lending rate (OVN), closed lower at 18.33% and 19.25%, respectively.

In the Nigerian Interbank Treasury Bills market, the Nigerian Interbank Treasury Bills True Yield (NITTY) witnessed a decrease across the 1-month, 3-month, and 6-month tenor options, with respective yields dropping by 81bps, 90bps, and 76bps. However, the average secondary market yield on Nigerian Treasury bills closed higher by a base point to 10.51%.

Bond Market

Trading in the bond market leaned bullish, as a result of a -93bps change in the MAR-24 paper, causing the average yield on FGN Bonds to decline by 4bps, to close at 15.87%.

In Nigeria's sovereign Eurobonds market, sell sentiment was evident across the short, mid, and long ends of the yield curve, resulting in a 2bps increase in the average yield to 10.86%.

Foreign Exchange Market

In the foreign exchange market, the Naira depreciated by 2.48% in the official market, closing at N814.60 to the dollar from N794.89 per dollar. In the parallel market, the Naira's performance remained subdued, closing at N1,158 against the US dollar.

Global Commodity Market

In the global commodity market, Brent Crude declined by 0.86% to trade at \$79.89 per barrel, while the WTI Crude also faced a decline of 0.73% to \$74.99 per barrel.
