





## Investors wealth Appreciates by N507.60bn as Market Cap Crosses Record N40 Trillion; Overnight NIBOR Dips as System Liquidity Improves....

Bullish sentiment continued to dominate the market as its All-Share Index gained 1.28% on the day, to close at 73,397.71 points. The market recorded N507.60 billion worth of investors gain, even as the Exchange accounted for more gainers (37) than losers (24). Notably, investors locked in more funds into stocks such as MULTIVERSE, TRANSCORP, INFINITY, ETRANZACT and CAVERTON, as they made the list for the top gainers for the day due to appreciable share price movements of 10.00%, 10.00%, 9.97%, 9.73% and 9.66%, respectively. Furthermore, trading activity on the NGX displayed robust performance as the total deals, volume and value increased by 15.14%, 34.88%, and 84.62% to 7,910 deals, 554.64 million units and N12.83 billion, respectively. Reflective of the positive market momentum, performance across the sub-sector gauges tracked was largely bullish. The NGX Banking, NGX Insurance, NGX Oil/Gas and NGX Industrial Goods indexes increased by 75bps, 83bps, 5bps and 11bps, respectively. However, the Consumer Goods sector was the only laggard for the day as it declined by 23bps. At the conclusion of the trading session, GTCO emerged as the most traded security in terms of volume and value with 89.45 million units worth N3.58 billion, changing hands in 362 deals.



## Money Market

In the money market, NIBOR rates fell across all tenor buckets, as the Overnight NIBOR declined by 3.73% to close at 16.94% indicating liquidity ease in the financial system. Likewise, key money market rates, such as the open repo rate (OPR) and overnight lending rate (OVN), decreased by 5.32% and 5.50% to close at 16.08% and 17.10%, respectively.

In the Nigerian Interbank Treasury Bills market, the Nigerian Interbank Treasury Bills True Yield (NITTY) displayed upward movement across tenor gauges. The 1-month, 3-month, 6-month and 12-month NITTY rates advanced by 0.01%, 0.33%, 0.55% and 0.09%, respectively. Meanwhile, the secondary market for Nigerian Treasury Bills witnessed positive movement at the longer end of the curve as the average T-bills yield declined by 13bps to close at 8.17% on Wednesday.

## Bond Market

Moving to the bond market, trading activity was mildly bearish as the average yield increased by a base point to close at 14.36%

However, in the Nigerian sovereign Eurobonds market, trading activity was largely bullish leading to a decline in the average yield by 13bps to 9.74% on Wednesday.

## Foreign Exchange Market

Shifting to the foreign exchange market, the Naira depreciated by 1.16% at the official market to close at N854.61 per dollar (from N844.85). However, in the parallel market, the Naira edged the dollar in strength by 1.07% as it appreciated to close at N1,205 to the dollar.

## Global Commodity Market

In the global commodity market, oil prices showed a positive trend above the \$70 per barrel mark, with Brent Crude increasing by 1.28% to trade at \$80.24 per barrel and WTI also rising by 1.31% to trade at \$74.91 per barrel on Wednesday.
