



Investors Increase Stake on Nigerian Equities with N1.82tn Profit; NIBOR Reverses Upward on Financial System Liquidity Strain....

At the close of Tuesday's session, the domestic bourse All-Share Index advanced by 3.93% to settle at 87,970.37 points, bringing the year-to-date gain of the index to 17.65%. Resultantly, market capitalization inched higher by 3.93% to N48.14 trillion largely influenced by position taking activities from which equity investors saw approximately N1.82 trillion in gains on Tuesday. Due to the bullish sentiment, several stocks such as BERGER (+10.00%), DANGSUGAR (+10.00%), FLOURMILL (10.00%), FTNCOCOA (+10.00%) and HONEYFLOUR (+10.00%) experienced significant price upticks even as the Exchange had more stocks gaining (77) than declining (10). The top five decliners for the day include ROYALEX (-8.16%), MULTIVERSE (-6.59%), ELLAHLAKES (-4.79%), OANDO (-3.60%) and UACN (-3.13%). Meanwhile, trading activity on the NGX stayed upbeat as the total deals, volume and value surged by 8.71%, 34.82%, and 45.46% to 14,835 trades, 1.09 billion units and N16.05 billion, respectively. A breakdown across sub-sector gauges tracked indicated gains as five of the five sub-indices closed in the green zone. NGX Banking, NGX Insurance, NGX Consumer Goods, NGX Oil/Gas and NGX Industrial Goods indexes recorded gains of 4.35%, 5.80%, 2.97%, 0.11% and 9.72%, respectively. At the close of the trading session, JAIZBANK emerged as the most traded security by volume with 150.64 million units worth N508.44 million, changing hands in 757 deals, while NASCON was the most traded security terms of value resulting in N2.57 billion.





Money Market

In the money market, NIBOR rates displayed upward trends across all tenor buckets as illiquidity cripples the system. Notably, the Overnight NIBOR rose by 2.00% to 19.5%. Also, the 1-month, 3-month and 6-month NIBOR increased by 2.31%, 1.88% and 1.00%, respectively. Key money market rates, including the open repo rate (OPR) and overnight lending rate (OVN), nosedived and concluded at 16.40% and 17.25%, respectively.

Meanwhile, the Nigerian Interbank Treasury Bills True Yield (NITTY) closed higher across all tenor buckets. The 1-month, 3-month, 6-month and 12-month NITTY rates increased by 21bps, 83bps, 50bps and 53bps, respectively. Nonetheless, the average secondary market yield on Nigerian Treasury Bills remained at 3.18%.

Bond Market

In the secondary market for FGN Bonds on Tuesday, market activity was on a cautious thread, as the value of the bonds closed flat for all maturities.

In Nigeria's sovereign Eurobonds market, the prevailing sentiment was bearish across all ends of the yield curve, causing an increase of 0.12% in the average yield to 9.93%.

Foreign Exchange Market

In the foreign exchange market, the Naira depreciated by 4.72% at the official market, closing at N878.57 to the dollar from N838.95 per dollar the previous day. Similarly, in the parallel market, the Naira traded weak on Tuesday, closing at N1,300 against the US dollar.

Global Commodity Market

In the global commodity market WTI crude futures declined by 0.57% to \$72.20 per barrel on Tuesday. Also, the Brent Crude declined by 0.15% to close at \$78.03 per barrel.
