




Bearish Sentiment Continues, Wipes Out N849 billion from Investors Pocket; NIBOR Falls as System Liquidity Improves.....

Bearish Sentiment continues as investors lose N849 billion at the close of Tuesday's trade. The Nigerian equities market suffered a massive loss, as its All-Share Index further declined by 1.50% to close at 102,108.05 points. Correspondingly, the market capitalization of listed equities plummeted by 1.50% to N55.87 trillion, resulting in a year-to-date return of 36.56% (from 38.63%). It is crucial to highlight that the Exchange accounted for more declining stocks (46) than advancing stocks (14). Significant sell-off was detected in BUACEMENT, CONHALLPLC, STERLINGNG, UPDC and TIP with share price depreciations by -10.00%, -10.00%, -9.85%, -9.79% and -9.79%, respectively. Furthermore, negative sentiment pervaded the market as trading on the NGX displayed bearish results, with the total deals, volume and value nosediving by 13.99%, 41.28% and 60.70% to 11,761 deals, 494.19 million units and N7.60 billion, respectively. Performance across the sectors indicated broad based losses as four out of the five sub-sector gauges tracked closed in the red zone. The Banking, Insurance, Consumer and Industrial Goods indexes declined by 2.27%, 1.00%, 0.22% and 3.79%, respectively. The Oil/Gas sector held steady from the previous session. Despite the overall bearish momentum, a few stocks recorded positive price movements, amongst which include JULI (+10.00%), CADBURY (+10.00%), MEYER (+9.94%), DAARCOMM (+9.09%) and CAP (+4.58%). At the close of the trading session, JAIZBANK took the spotlight as the most traded security in terms of volume with 90.78 million units, traded across 433 deals, while GTCO led in traded value at N1.32 billion.



Money Market

In the money market, NIBOR trended lower across all maturity gauges, reflecting Liquidity ease in the system. The Overnight, 1-month, 3-month and 6-month NIBOR rates declined by 3.66%, 0.32%, 0.32% and 0.29%, respectively. Key money market rates, such as the open repo rate (OPR) and overnight lending rate (OVN) declined by 6.10% and 5.90% to 16.00% and 17.00%, respectively.

In the Nigerian Interbank Treasury Bills market, NITTY closed in the mix. The 1-month and 12-month NITTY declined by 37bps and 24bps, while the 3-month and 6-month NITTY rates increased by 18bps and 92bps, respectively. The average secondary market yield on T-bills increased by 192bps to 11.60% on bearish sentiments.

Bond Market

In the secondary market for FGN Bonds, trading on Tuesday exhibited slight bearish results. The average yield increased by 3bps to close at 15.32%.

In Nigeria's sovereign Eurobonds market, there was a negative level of activity. Sell sentiment was evident across all ends of the yield curve, leading to an increase in the average yield by 5bps to 10.09%.

Foreign Exchange Market

Turning to the foreign exchange market, the Naira depreciated yet again by 0.99% to close at N1,433.89 per dollar. In the parallel market, the Naira traded weak on Tuesday to close at N1,455 against the US dollar.

Global Commodity Market

In the global commodity market WTI crude futures advanced by 0.79% to \$73.34 per barrel on Tuesday. Also, the Brent Crude closed higher at \$78.66 per barrel.
