



## Domestic Bourse Opens up the Week with a 0.18% Gain; NIBOR Falls as System Liquidity Eases.....

The domestic equities market commences the trading week in a bullish run, with the All-Share Index advancing by 0.18% to 102,042.32 points; even as the Exchange recorded more gainers (32) than laggards (23). Correspondingly, the market capitalization of listed equities experienced a parallel upswing by 0.18%, equivalent to N100.65 billion worth of gains, to close at N55.84 trillion. The top five advancers for the day include CHAMS, NCR, ROYALEX, SUNUASSUR and TIP, with positive share price movements by +10.00%, +10.00%, +10.00%, +9.50% and +9.43%, respectively. Conversely, INFINITY, JOHNSHOLT, PZ, MAYBAKER and DEAPCAP suffered losses by -9.90%, -9.88%, -9.87%, -9.80% and -7.14%, respectively. Moving forward, sectoral performance stayed relatively positive as three of the five sub-indices tracked close in the green zone: NGX Insurance, NGX Consumer Goods and NGX Oil/Gas indexes recorded gains of 2.30%, 0.60% and 0.15%, respectively. However, the Banking and Industrial Goods sectors posted losses of 0.88% and 0.07%. Trading activity on the NGX dwindled despite the rise in the benchmark index. The total deals, volume and traded value declined by 2.35%, 24.68% and 30.31%, to 8,715 trades, 242.43 million units and N5.13 billion, respectively. At the conclusion of the trading session, ACCESSCORP emerged as the most traded security in terms of volume with 24.90 million units, changing hands in 662 deals, while GTCO was the most traded in terms of value amounting to N841.25 million.





## Money Market

In the money market, NIBOR rates trended lower across all tenor buckets reflecting an improvement in the liquidity system. Notably, the Overnight NIBOR declined by 1.94% to close at 17.00%. In the same manner, the 1-month, 3-month and 6-month NIBOR decreased by 0.94%, 0.81% and 1.09%, respectively. Likewise, key money market rates, such as the open repo rate (OPR) and overnight lending rate (OVN) declined by 0.12% and 0.90% to 15.38% and 16.10%, respectively.

In the Nigerian Interbank Treasury Bills market, yields across the 1-month, 3-month, and 6-month NITTY maturity periods declined by 54bps, 79bps, and 38bps, respectively. The secondary market for Nigerian Treasury Bills experienced bullish movements on Monday. Thus, average T-Bills yield declined marginally by 2 basis points to close at 14.69%.

## Bond Market

In the secondary market for FGN Bonds, trading activity was in a bearish mode as the average yield increased by 5 basis points to 15.54%. This was as a result of yield expansion of 1.25% in the JUN-33 FGN paper.

In Nigeria's sovereign Eurobonds market, there was a negative level of activity. Sell sentiment was evident across the yield curve, leading to an increase in the average yield by 0.01% to 9.79%.

## Foreign Exchange Market

Turning to the foreign exchange market, the Naira depreciated by 4.38% to close at N1,534.39 per dollar from N1,469.97. Similarly, in the parallel market, the Naira weakened by 1.22% to close at N1,488 against the US dollar.

## Global Commodity Market

In the global commodity market WTI crude futures declined by 0.07% to \$76.79 per barrel on Monday. Also, the Brent Crude decreased by 0.46% to close at \$81.81 per barrel.
