



## Equity Market Gains N329 billion as Investors Take a Bet on Value Stocks; NIBOR Falls as System Liquidity Eases.....

The local bourse All-Share Index rose further by 0.58% to close at 104,100 points. Hence, the year-to-date gain of the index climbed to 39.22%; although the Exchange printed more losers (26) than gainers (24). The equities market recorded N329.25 billion in gains resulting in a market cap of N56.96 trillion. Notably, gains from stocks such as UPL (+9.96%), JULI (+9.84%), MBENEFIT (+9.38%), DAARCOMM (+8.82%), and HONEYFLOUR (+7.50%) contributed to the upward movement of the ASI. Given the bullish mood, performance across sub-sector gauges tracked was relatively positive as the NGX Insurance, NGX Consumer Goods and NGX Industrial Goods indices increased by 0.18%, 0.22% and 1.95%, respectively. The Banking index recorded a decline of 1.32%, while the Oil/Gas sector had a lull performance. Unfortunately, despite the rise in ASI today, trading activity on the NGX witnessed a lackluster trend, with total traded value nosediving by 42.89% to N6.91 billion. The total traded volume also plunged by 33.35% to 284.49 million units, followed by a 5.62% decline in total deals, totaling 8,168 trades. The major decliners for the day include stocks such as UNILEVER (-9.80%), JBERGER (-9.64%), MORISON (-9.60%), MAYBAKER (-6.52%) and NASCON (-5.37%), experiencing negative share price movements. As the session concluded, GTCO emerged as the most traded security in terms of volume and value, with 56.61 million units worth N2.22 billion, changing hands in 326 deals.





## Money Market

In the money market, NIBOR rates trended downwards across all maturity gauges. Notably, the Overnight NIBOR declined by 0.80% to settle at 15.45%, as a result of liquidity ease. Similarly, key money market rates, such as the open repo rate (OPR) and overnight lending rate (OVN) nosedived to conclude at 14.50% and 15.11%, respectively.

In the Nigerian Interbank Treasury Bills market, the Nigerian Interbank Treasury Bills True Yield displayed upward movement across tenor gauges with the exception of the 1-month NITTY which declined by 2bps. Concurrently, the 3-month, 6-month and 12-month NITTY advanced by 18bps, 31bps, and 98bps, respectively. However, the secondary market for Nigerian Treasury Bills contracted by 20 basis points to settle at 14.40% on Thursday.

## Bond Market

In the secondary market for FGN Bonds, trading activity was slightly negative, leading to an increase in the average yield by 25bps to 16.10%.

In Nigeria's sovereign Eurobonds market, positive sentiment prevailed across all segments of the yield curve, causing a 21bps decrease in the average yield to 9.72%.

## Foreign Exchange Market

Turning to the foreign exchange market, the Naira appreciated by 0.34% to close at ₦1,498.25 per dollar. In the parallel market, the Naira closed at ₦1,600 against the US dollar.

## Global Commodity Market

In the global commodity market WTI crude futures advanced by 1.05% to \$77.45 per barrel on Thursday. Also, the Brent Crude increased by 0.92% to close at \$82.35 per barrel.
