



Bears Resurface as ASI Dips by 1.23% Amid Mixed Sub-Sector Performance; Naira Gains 2.94%, Closes at ₦1,548.25 per Dollar in Official Forex Market....

The trading week ended with a bearish tone, marked by a 1.23% decline in the NGX All-Share Index, closing at 98,751.98 points. Although there was a notable positive turnout on the exchange, with 47 gainers surpassing 8 losers, trading activity saw a sharp decline. Total deals, volume, and value dropped by 4.99%, 32.29%, and 22.01%, respectively, to 9,168 trades, 367.62 million units, and N6.78 billion. This led to a decrease in the market capitalization of listed equities by 1.23% to N54.04 trillion, resulting in a total market loss of N672.12 billion. Performance across various sub-sectors exhibited a mixed trend. The Banking sector led the gainers with a 2.59% increase, driven by buy interest in ACCESSCORP, STERLINGNG, WEMA, UBA, and ZENITH. The Insurance and Consumer goods indexes followed suit with gains of 1.12% and 0.38%, respectively, particularly influenced by LINKASSURE, MANSARD, AIICO, PZ, HONEYFLOUR, DANGSUGAR, and FLOURMILLS. On the other hand, the Oil/Gas and Industrial Goods indexes posted losses of 0.85% and 3.44%, attributed to sell sentiment in CONOIL and BUACEMENT. Among individual stocks, the top five advancers for the day were FTNCOCOA, TIP, JULI, CHAMPION, and PZ, with gains of +10.00%, +10.00%, +9.97%, +9.94%, and +9.93%, respectively. Conversely, bellwether stocks such as BUACEMENT, CONOIL, MTNN, NASCON, and FIDELITY witnessed share price declines of -10.00%, -10.00%, -9.96%, -3.94%, and -3.85%, respectively, contributing to the overall market downturn. At the close of the session, TRANSCORP emerged as the most traded security in terms of volume, with 56.99 million units exchanged in 690 trades, while ZENITHBANK led in traded value at N913.43 million..



Today's biggest transactions by %age of total naira votes







Money Market

In the money market, the Overnight NIBOR increased by 270 basis points to close at 26.64%. In the same manner, key money market rates, including the open repo rate (OPR) and overnight lending rate (OVN), surged to conclude at 27.16% and 28.19%, respectively.

Within the NITTY space, rates moved downward for most maturity gauges, with declines of 8 basis points, 27 basis points, and 47 basis points for the 3-month, 6-month, and 12-month periods. Resultantly, the secondary market for Nigerian Treasury Bills closed with marginal positive movement, causing a mild 0.01% decline in the average T-bills yield to 16.60%.

Bond Market

In the bond market, secondary market activity for FGN Bonds was mildly bearish, resulting in a 0.03% increase in the average secondary market yield to 17.25%.

In the sovereign Eurobonds market, positive sentiment was observed across all ends of the yield curve, causing a decline in the average yield by 11 basis point to 9.85%.

Foreign Exchange Market

Turning to the foreign exchange market, the naira appreciated by 2.94% to close at ₦1,548.25 per dollar in the official market. In the parallel market, Naira closed at ₦1,515 against the US dollar on Friday.

Global Commodity Market

In the global commodity market, Brent crude increased by 1.34% to close at \$83.01 per barrel. Similarly, WTI crude advanced by 1.70% to \$79.59 per barrel.
