




Bearish Momentum Grows at Midweek Amidst Renewed Interest in Financial Stocks; Naira Surges 6.57% Against Dollar in FX Market.....

Midweek trading on the Nigerian Stock Exchange reveals growing bearish momentum as the equities market continues its freefall. The benchmark index recorded a further loss of 0.80% to close the session at 99,909.54 points. Concurrently, the market capitalization of listed equities also dwindled by 0.80% to N56.51 trillion, reflecting a total market loss of N456.66 billion. This negative downturn was reflected on the trading activity levels. The total deals, volume and value plummeted by 10.78%, 20.11%, and 30.56%, to settle at 9,074 trades, 322.66 million units and N5.82 billion, respectively. Furthermore, the Exchange accounted for more losers (27) than gainers (17). The top five decliners for the day include LIVESTOCK (-10.00%), CWG (-9.79%), INTENEGINS (-9.79%), FTNCOCOA (-9.72%), and AFRIPRUD (-9.42%), all recording substantial share price depreciations. Despite the negative market movement, performance across the sub-sectors showed an improvement. NGX Banking, NGX Insurance, and NGX Industrial Goods indices advanced by 1.10%, 0.58%, and 0.01%, respectively. However, NGX Consumer Goods index declined by 0.05%, while NGX Oil/Gas remained unchanged from the previous session. At the close of the session, UBA took the lead as the most traded security in terms of volume with 55.01 million units transacted in 1,092 trades, while ZENITHBANK led in traded value at N1.69 billion.





Money Market

In the money market, the Overnight NIBOR increased by 155bps to close at 32.93%, indicating a shortage of liquidity in the system. Likewise, Key money market rates like the open repo rate (OPR) and overnight lending rate (OVN) surged to conclude at 32.09% and 33.34%, respectively.

In the Nigerian Interbank Treasury Bills market, the Nigerian Interbank Treasury Bills True Yield (NITTY) increased across maturity gauges. However, In the secondary market for Nigerian Treasury Bills, the average yield stayed muted at 17.46%, despite positive trading activity levels.

Bond Market

In the secondary market for FGN Bonds, the average yield declined marginally by 0.01% to close at 19.26%.

In Nigeria's sovereign Eurobonds market, trading activity exhibited a bullish trend, resulting in a decline in the average yield by 0.15% to 10.04%

Foreign Exchange Market

In the foreign exchange market, the Naira appreciated by 6.57% at the official market, closing at ₦1,072.74 to the dollar from ₦1,148.14 per dollar the previous day. In the Parallel market, the Naira closed at ₦1,045 to the dollar.

Global Commodity Market

At 3:30 p.m. GMT+1, oil prices experienced a notable downturn, characterized by a negative shift. Specifically, Brent crude saw a decline of 1.27%, settling at \$88.87 per barrel, while WTI crude also exhibited a decrease, dipping by 1.24% to \$84.30 per barrel.
