




## Weak Sentiment Persists as ASI Pullback by 6bps; Naira Dips 7.58% Against Dollar in FX Market.....

At the close of Thursday's trading session, the local bourse's All-Share Index declined by 6bps, closing at 99,845.91 points. Consequently, the market capitalization of listed equities dropped by N35.85 billion, closing at N56.47 trillion. Trading activity levels also decreased, with total deals, volume, and value plunging by 14.86%, 11.39%, and 4.77%, totaling 7,726 trades, 285.91 million units, and N5.54 billion, respectively. The Exchange also saw more declining stocks (19) than advancing ones (16). Leading the losers' chart were UCAP (-9.73%), CONHALLPLC (-9.70%), CWG (-9.52%), CHAMS (-9.14%), and SUNUASSUR (-8.26%), all experiencing significant share price reductions. Performance across sub-sectors displayed varied trends. The Insurance and Consumer Goods indices advanced by 0.03% and 0.14%, respectively, while the Oil/Gas and Industrial Goods indices remained steady from the previous session. However, the Banking index declined by 0.63%. ACCESSCORP emerged as the most traded stock in terms of volume, with 43.98 million units traded across 703 deals, while GTCO led in traded value, amounting to N1.14 billion.





## Money Market

In the money market, the Overnight NIBOR decreased by 0.46% to close at 32.47%, reflecting liquidity ease in the system. Likewise, Key money market rates like the open repo rate (OPR) and overnight lending rate (OVN) nosedived to conclude at 30.21% and 31.30%, respectively.

In the Nigerian Interbank Treasury Bills market, the Nigerian Interbank Treasury Bills True Yield (NITTY) increased across most maturity gauges. However, In the secondary market for Nigerian Treasury Bills, the average yield declined marginally by 0.01% to close at 17.45%.

## Bond Market

In the secondary market for FGN Bonds, the average yield inched higher by 0.01% to close at 19.26%.

In Nigeria's sovereign Eurobonds market, trading activity exhibited a bullish trend, resulting in a decline in the average yield by 0.09% to 9.95%

## Foreign Exchange Market

In the foreign exchange market, the Naira depreciated by 7.58% at the official market, closing at ₦1,154.08 to the dollar. In the Parallel market, the Naira closed at ₦1,055 to the dollar.

## Global Commodity Market

At 3:30 p.m. GMT+1, oil prices experienced a notable downturn, characterized by a negative shift. Specifically, Brent crude saw a decline of 0.56%, settling at \$86.80 per barrel, while WTI crude also exhibited a decrease, dipping by 0.47% to \$82.30 per barrel.
