Bears Maintain Control as Local Bourse Records 120bps Downturn; Naira Depreciates by 0.64% Against Dollar in Forex Market.....

Equity market investors continued to face losses as bearish sentiment persisted during midweek trading. The All-Share Index experienced a significant decline of 1.20%, closing the session at 98,121.30 points and further reducing the year-to-date return to 31.22%. Key stocks driving the market downturn included MTNN, TRANSCOHOT, OANDO, and FBNH, with share price losses of -10.00%, -10.00%, -9.90%, and -9.82%, respectively, resulting in a total investor wealth loss of N673.16 billion. Overall, the market capitalization of listed equities declined by 1.20% to N55.49 trillion. However, despite the overall decline, the Exchange recorded more advancing stocks (22) than declining stocks (19). This shift was reflected in trading activity levels on the NGX, with total deals and value experiencing gains of 7.96% and 22.10%, totaling 7,907 trades and N9.58 billion. Conversely, traded volume for the day saw a decline of 31.10% to 395.75 million units. Sectoral performance exhibited a mixed trend, with the Banking and Insurance sectors posting losses of 0.83% and 0.27% due to sell-offs in FBNH, UBA, AIICO, WAPIC, MBENEFIT, CORNERST, and SOVRENINS. On the other hand, the Consumer and Industrial Goods sectors gained 0.05% and 0.02%, driven by positive interest in UNILEVER, CAP, and CUTIX, while the Oil/Gas sector remained steady from the previous session. GTCO emerged as the most traded security in terms of volume and value, followed by ZENITHBANK.

Money Market

In the money market, Overnight NIBOR rate decreased by 4 basis points, settling at 31.46%, indicating an easing of liquidity. Key money market rates such as the open reporate (OPR) and overnight lending rate (OVN) closed at 29.35% and 31.33%, respectively.

In the Nigerian Interbank Treasury Bills market, the Nigerian Interbank Treasury Bills True Yield (NITTY) exhibited an upward trend across tenor gauges. NITTY rates increased by 1.64%, 0.96%, and 0.74% for the 1-month, 3-month and 6-month periods. However, the average secondary market yield for Nigerian Treasury Bills declined by 0.02% to close at 24.89%.

Bond Market

In the secondary market for FGN Bonds, trading activity was on a cautious thread, as a result, the average yield declined marginally by 0.01% to close at 18.97%.

In Nigeria's sovereign Eurobonds market, negative trading activity contributed to a rise in the average yield by 0.07% to 9.90%.

Foreign Exchange Market

In the foreign exchange market, the Naira experienced a 0.64% depreciation against the dollar, concluding at \$1,308.52 at the official rate, and \$1,305 in the parallel market.

Global Commodity Market

At 3:30 p.m. GMT+1, Oil prices experienced a mixed outcome. Brent crude increased by 0.07%, to close at \$88.52 per barrel, meanwhile WTI crude saw a decline, dropping by 0.16% to \$83.33 per barrel.
