





## Local Bourse Sees Marginal Increase as All-Share Index Edges Up; NIBOR Declines on System Liquidity Ease.....

The local bourse closed the session with a marginal increase, as the All-Share index edged up by 5 basis points to settle at 98,169.30 points. Similarly, the market capitalization of listed equities saw a slight uptick of 0.05% to reach N55.52 trillion. Noteworthy contributors to today's gains included TRANSCOHOT, LIVESTOCK, TANTALIZER, SUNUASSUR, and WAPIC, posting share price increases of 9.75%, 9.42%, 9.38%, 7.44%, and 6.15%, respectively. However, despite the overall uptrend, the Exchange recorded more losers (24) than gainers (16), reflecting subdued trading activity. Total deals, volume, and value all experienced declines, down by 6.20%, 24.90%, and 31.95%, totaling 7,417 trades, 297.20 million units, and N6.52 billion, respectively. Sectoral performance was mixed, with the Banking and Consumer Goods indexes declining by 1.10% and 0.05%, while the Insurance index gained 0.88%. The Oil/Gas and Industrial Goods indexes remained unchanged. ZENITHBANK emerged as the most traded security by volume and value, with 48.49 million units valued at N1.77 billion exchanged in 577 deals.





## Money Market

In the money market, NIBOR rates decreased across board for all tenor buckets, reflecting improved liquidity in the financial system. Notably, the Overnight NIBOR decreased by 121 basis points, settling at 30.25%. In the same manner, key money market rates such as the open repo rate (OPR) and overnight lending rate (OVN) nosedived to conclude at 27.08% and 28.35%, respectively.

In the Nigerian Interbank Treasury Bills market, the Nigerian Interbank Treasury Bills True Yield (NITTY) exhibited a downward trend across tenor gauges. NITTY rates decreased by 0.27%, 0.65%, 0.20%, and 0.66% for the 1-month, 3-month, 6-month and 12-month periods. Thus, the average secondary market yield for Nigerian Treasury Bills declined by 3.10% to close at 21.79%.

## Bond Market

In the secondary market for FGN Bonds, trading activity was on a cautious thread, as a result, the average yield declined marginally by 0.01% to close at 18.96%.

In Nigeria's sovereign Eurobonds market, negative trading activity contributed to a rise in the average yield by 0.13% to 10.03%.

## Foreign Exchange Market

In the foreign exchange market, the Naira experienced a 0.10% depreciation against the dollar, concluding at ₦1,309.88 at the official rate, and ₦1,400 in the parallel market.

## Global Commodity Market

At 3:30 p.m. GMT+1, Oil prices experienced a negative outcome. Brent crude decreased by 0.52%, to close at \$87.44 per barrel, and WTI crude saw a decline, dropping by 0.68% to \$82.14 per barrel.
