




## Market Cap Slips Further by N133bn as Bears Maintain Dominance; Naira Skids to ₦1,520.40 Per Dollar at Official Market....

The local equities market saw a slight dip of 24 basis points, with the All-Share Index settling at 97,473.98 points, despite witnessing more gainers (22) than losers (20). This decline translated to a decrease in the market capitalization of listed equities by N132.65 billion, marking a 0.24% decrease to close at N55.13 trillion. Share prices of DANGSUGAR, PZ, TIP, NEM, and CAVERTON dwindled by -10.00%, -10.00%, -10.00%, -9.66%, and -9.55%, respectively, thereby contributing to the market downturn. In the same manner, trading activity suffered massive declines, with the total deals, volume and value plummeting by 7.62%, 30.18%, and 48.90%, to 7,951 deals, 306.60 million units, and N5.81 billion, respectively. Sectoral performance mirrored the market's bearish sentiment, as evidenced by declines of 1.02%, 1.09%, and 0.81% in the Banking, Insurance, and Consumer Goods indices, respectively. However, the Industrial Goods index saw a marginal rise of 0.02%, while the Oil/Gas sector remained stable from the previous session. As trading concluded, ACCESSCORP emerged as the most traded security in terms of volume, with 33.23 million units transacted in 746 trades, while GTCO led in traded value, amounting to N1.36 billion.





## Money Market

In the money market, the Overnight NIBOR increased by 0.21% to reach 30.75% due to tightening liquidity conditions. Short-term benchmark rates such as the open repo rate (OPR) and overnight lending rate (OVN), advanced by 0.83% and 0.98% to reach 29.69% and 30.59%, respectively.

NITTY traded higher for most tenor buckets. However, the average secondary market yield on Nigerian Treasury Bills cleared lower by a base point to close at 21.36%.

## Bond Market

In the secondary market for FGN Bonds, trading activity was slightly on the bearish side, as the average yield increased by 2-basis points to reach 18.64%.

In the sovereign Eurobonds market, sell sentiment was evident across all segments of the yield curve, resulting to an increase in the average yield by 0.02% to 9.84%.


## Foreign Exchange Market

In the foreign exchange market, the Naira depreciated against the dollar by 2.86% to close at ₦1,520.40 per dollar in the official market. In the parallel market, the Naira closed at ₦1,515 against the US dollar.

## Global Commodity Market

At 3:30 p.m. GMT+1, oil prices declined as Brent crude dipped by 0.78% to \$82.71 per barrel, while West Texas Intermediate (WTI) crude also fell by 0.83% to \$78.47 per barrel on Tuesday.
