
# Cowry Daily Market Insight 05 June 2024

MPR: 26.25% Apr'24 Inflation Rate: 33.69% Q1 2024 Real GDP: 2.98%

Market Rebounds by 0.24% At Midweek on Positive Sentiment; Naira Crashes Across FX Markets....

The Local Bourse All-Share Index increased by 0.24% to 99,284.38 points at the close of Wednesday's session. Similarly, the market capitalization of listed equities advanced by 0.24% to N56.16 trillion. The top five gainers for the day include ETERNA, REDSTAREX, STANBIC, FIDELITY and INTBREW, with share price appreciations of 9.80%, 9.76%, 9.62%, 8.00%, and 7.84%, respectively. Trading activity on the NGX weakened, as the total deals, volume and value declined by 3.61%, 2.77%, and 33.45%, totaling 7,690 deals, 308.14 million units, and N4.86 billion, respectively. Performance across the sectors was quite bullish. The Banking, Consumer Goods and Oil/Gas indexes recorded gains of 2.46%, 0.15%, and 0.26%, while the Insurance and Industrial Goods indices posted losses of 1.49% and 0.01%, respectively. At the conclusion of the session, FIDELITYBANK emerged as the most traded security of volume and value, with 84.05 million units worth N883.22 million, transacted terms

## **Money Market**

In the money market, the overnight NIBOR advanced by 3.78% to hit 30.17%, as illiquidity pressure rises. Additionally, key money market rates such as the Open Repo Rate (OPR) and Overnight Lending Rate (OVN) advanced by 1.74% and 1.76% to reach 29.68% and 30.26%, respectively.

In the Nigerian Interbank Treasury Bills market, the Nigerian Interbank Treasury Bills True Yield (NITTY) exhibited upward movements on Wednesday across tenor options. However, the average secondary market yield on Nigerian Treasury Bills experienced a bullish trend, declining by 0.01% to 20.07%

#### **Bond Market**

In the secondary market for FGN Bonds, the average yield increased marginally by 0.03% to close at 18.73%.

The sovereign Eurobonds market displayed a bearish trend, thus resulting in an increase in the average yield by 0.01% to 9.83%.

## Foreign Exchange Market

In the foreign exchange market, the Naira depreciated by 0.79% in the official NAFEM market, trading at ₹1,488.60 per dollar. Similarly, the parallel market saw the Naira weaken by 2.68%, ending at N1,494 per dollar.

## **Global Commodity Market**

At 3:30 p.m. GMT+1, Oil prices experienced a positive outcome. Brent crude increased by 0.21% to \$77.69 per barrel, and WTI crude saw an increase of 0.43% to \$73.57 per barrel on Wednesday.
