

Bloodbath on NGX as Investors React to Rate Hike with Widespread Sell-off; Overnight NIBOR Surges Amidst Tightening Liquidity, CBN Rate Hike...

The equities market experienced a bearish reversal as investors reacted to the CBN interest rate hike by offloading equity stocks. This resulted in an 8 basis points (bps) decline in the All-Share Index, which closed at 100,486.12 points, and a market capitalization decrease of N46.70 billion, ending at N56.89 trillion. Negative sentiment was evident, with 27 declining stocks outpacing 14 gainers on the Exchange. Trading activity was largely downbeat, with declines of 4.08%, 16.32%, and 2.46% in the number of deals, traded volume, and value, respectively. This translated to 8,403 deals, 280.92 million units, and \(\frac{1}{2}\)3.63 billion in value. The major contributors to the day's losses included UPL (-9.92%), JOHNHOLT (-9.87%), OMATEK (-9.46%), DEAPCAP (-8.93%), and NSLTECH (-7.02%), each recording significant share price declines. Sectoral performance was mostly negative, particularly in the Banking and Insurance sectors, which declined by 0.67% and 0.15%, respectively. However, the Consumer Goods sector emerged as the sole gainer for the day, with a 0.06% increase, while the Oil/Gas and Industrial Goods sectors remained steady from the previous session. 

Money Market

The Nigerian Interbank Offered Rate (NIBOR) advanced across tenors, with the Overnight NIBOR notably increasing by 435 basis points to 28.89%. This surge reflects tightening liquidity levels in the financial system, following the CBN's announcement of interest rate hike. In the same vein, key money market rates such as the Open Repo Rate (OPR) and Overnight Lending Rate (OVN) also increased, closing at 31.25% and 31.91% (from 25.34% and 25.81%), respectively.

The Nigerian Interbank Treasury Bills True Yield (NITTY) rates closed bullish across all tenor buckets as investors reacted to the interest rate hike, indicating positive sentiment in the T-bills space. Consequently, the secondary market for Nigerian Treasury Bills was active and bullish, leading to a 0.01% decrease in the average T-bills yield, bringing it to 22.55%.

Bond Market

Trading activity at the secondary FGN Bonds market was mildly bearish, leading to a 0.01% increase in the average yield to 19.42%.

In the sovereign Eurobonds market, positive sentiment was observed across all maturities, resulting in a 6-basis points decline in the average yield to 9.93%.

Foreign Exchange Market

In the official NAFEM market, the naira closed at ₹1,548.76 per dollar, depreciating by 3.23% from the previous close. In the parallel market, the naira weakened by 0.65%, ending the day at an average of ₹1,545 per dollar.

Global Commodity Market

In the global commodity market, oil prices fell further from the previous trade. The WTI crude futures dropped to \$76.65 per barrel on Tuesday, and the Brent Crude traded lower at \$80.79 per barrel.
