
Market Suffers Midweek Slump as Sell-offs Spur 0.20% Retracement in ASI; NIBOR Declines as Liquidity Conditions Improve....

The local bourse experienced another downturn at midweek, with the All-Share Index falling by 0.20% to 97,199.60 points. This decline reflected a negative shift in investor sentiment, as 25 stocks recorded losses compared to 22 gainers. Consequently, the market capitalization of listed equities decreased by 0.20% to N55.19 trillion, resulting in a total market loss of N108 billion. Trading activity was subdued, with total deals, volume, and value declining by 25.56%, 47.38%, and 60.62%, respectively, to 8,365 deals, 315.30 million units, and N5.48 billion. Sector performance was broadly negative, with the Banking, Insurance, Consumer Goods, Oil/Gas, and Industrial Goods sectors experiencing declines of 0.30%, 0.90%, 0.17%, 0.17%, and 0.02%, respectively. On the individual stock front, notable decliners included OANDO (-9.95%), CUTIX (-9.92%), ACADEMY (-8.70%), JAPAULGOLD (-7.89%), and REDSTAREX (-6.98%). Conversely, GUINEAINS (+10.00%), SFSREIT (+9.96%), RTBRISCOE (+9.87%), HONEYFLOUR (+9.87%), and NSLTECH (+7.14%) emerged as the top gainers. At the end of the session, VERITASKAP led in volume with 38.42 million units traded across 220 deals, while GTCO topped in traded value with N1.65 billion.



Money Market

In the money market, NIBOR rates decreased on Wednesday as the financial system adjusted to improved liquidity conditions, reversing the recent upward trend. Specifically, the Overnight, 1-month, 3-month, and 6-month NIBOR rates fell by 131bps, 75bps, 71bps, and 33bps, respectively. Additionally, the Open Repo Rate (OPR) and Overnight Rate (O/N) decreased by 244bps and 192bps, settling at 34.17% and 35.06%, respectively.

The Nigerian Interbank Treasury Bills True Yield (NITTY) experienced a downward trend across all maturities, influenced by sell pressures from traders seeking to capitalize on higher yields elsewhere. Meanwhile, the secondary market for Nigerian Treasury Bills exhibited a bullish trend, with the average yield decreasing by 0.02% to 23.38%.

Bond Market

Trading in the FGN bond market was positive, with the average secondary market yield decreasing by 0.04% to 19.93%.

Nigeria's sovereign Eurobonds market saw bullish sentiment across the short, mid, and long segments of the yield curve, resulting in a 0.04% decline in the average yield to 10.45%.

Foreign Exchange Market

In the official NAFEM market, the naira weakened against the US dollar, depreciating by 0.25% to \$1,586.04 per dollar. In the parallel market, the naira closed at an average of \$1,585 per dollar.

Global Commodity Market

At 3:30 p.m. GMT+1 on Wednesday, Brent crude fell by 0.31% to \$80.44 per barrel, and West Texas Intermediate (WTI) crude declined by 0.46% to \$77.99 per barrel. WTI futures extended their losses for the second consecutive day following an unexpected rise in U.S. crude oil stocks reported by the EIA.
