




## Market Kicks Off Week on a High Note, ASI Inches Up 3bps, Naira Depreciates by 2.31% at the Official Market ....

The local stock exchange commenced the trading week on a positive trajectory, as the All-Share Index (ASI) rose by 0.03%, closing at 97,747.27 points. This modest increase lifted market capitalization by an equivalent margin to ₦59.23 trillion, adding ₦15.3 billion to investors' portfolios. The year-to-date (YTD) return remained robust at 30.72%. Sectoral performance was mixed. The banking, consumer goods, and oil/gas sectors experienced declines of 0.58%, 0.27%, and 0.08%, respectively. Conversely, the insurance and industrial goods sectors posted gains of 0.42% and 0.66%. Market breadth was positive, with 29 stocks advancing against 21 decliners. Leading gainers included JOHNHOLT, EUNISELL, BETAGLAS, TRANTALIZER, and ACADEMY, while top losers featured MECURE, TIP, THOMASWY, UPL, and CHAMPION. Trading activity was robust, though the total trading value dipped by 21.15%. Deal count and trade volume, however, saw increases of 6.77% and 40.03%, respectively, with 413.35 million shares traded across 9,004 deals, amounting to ₦5.34 billion. JAPPAULGOLD emerged as the most traded stock by volume, with 179 million units worth ₦379.8 million exchanged in 94 transactions.




## Money Market

In the money market, the Nigerian Interbank Offered Rate (NIBOR) rose across most maturities, with the exception of the Overnight NIBOR, which declined by 1.29% to settle at 25.09%, reflecting improved liquidity in the banking system. Similarly, the Open Repo Rate (OPR) and Overnight Lending Rate (O/N) recorded significant decreases of 0.91% and 1.19%, closing at 25.18% and 25.69%, respectively.

The Nigerian Interbank Treasury Bills True Yield (NITTY) experienced mixed movements across all maturities, while the average secondary market yield on T-bills eased by 0.05%, settling at 24.11%.

## Bond Market

Trading activity in the secondary market for FGN bonds was negative which led to a marginal increase in the average yield to 19.44%.

In Nigeria's sovereign Eurobonds market, sell pressure across the short, mid, and long ends of the yield curve led to a 24 basis points increase in the average yield to 9.90%.

## Foreign Exchange Market

In the foreign exchange market, the Naira depreciated by 2.31%, closing at ₦1,690.37 per dollar at the official market. In the Parallel market, the Naira closed at ₦1,735 to the dollar.

## Global Commodity Market

On Monday, global oil prices climbed in the commodity market, with Brent Crude gaining 1.20% to reach \$71.90 per barrel and West Texas Intermediate (WTI) rising by 0.97% to \$67.70 per barrel.
