Nigeria Bourse Records N137.6bn Boost in New Week Amid Broad Sector Gains, Overnight NIBOR Declines, Reflecting Liquidity in the Banking System

The local stock exchange opened this week's trading on a positive trajectory, as the All-Share Index (ASI) advanced by 0.23% to close at 97,733.86 points. This uptick contributed #137.6 billion to market capitalization, raising it to #59.25 trillion, while the year-to-date (YTD) return inched up to 30.71%. Sectoral performance was broadly positive, with notable gains in banking (+0.08%), insurance (+2.14%), consumer goods (+0.67%), oil and gas (+0.37%), and industrial goods (+0.89%). Market sentiment favored the bulls, with 36 stocks appreciating against 25 decliners. Leading the gainers were ABBEYBDS, AFRIPRUD, SOVRENINS, TANTALIZER, and LASACO, while ETRANZACT, NCR, FTNCOCOA, HONYFLOUR, and NPFMCRFBK topped the losers' chart. Trading activity was mixed, as volume (-13.45%) and value (-33.77%) declined, but the number of deals increased by 21.79%. A total of 446.19 million shares valued at #9.99 billion were traded across 9,200 transactions. JAPAULGOLD emerged as the most actively traded stock, with 72 million shares worth #161.8 billion exchanged in 142 deals.

Money Market

In the money market, the Nigerian Interbank Offered Rate (NIBOR) increased across most maturities, except for the Overnight NIBOR, which decreased by 1.12% to 29.63%, indicating sufficient liquidity in the banking system. Similarly, the Open Buy Back (OBB) rate and the Overnight Lending Rate (O/N) saw declines of 2.07% and 2.02%, settling at 27.18% and 27.89%, respectively.

The Nigerian Interbank Treasury Bills True Yield (NITTY) experienced upward movements across most maturities. Likewise, the average secondary market yield on Treasury bills moderated by 0.05% to 25.11%.

Bond Market

Trading activity in the secondary market for FGN bonds stayed muted in the average yield to 19.46%.

In Nigeria's sovereign Eurobonds market, sell-offs across the short, mid, and long segments of the yield curve resulted in a 0.04% increase in the average yield, bringing it to 9.66%.

Foreign Exchange Market

In the foreign exchange market, the Naira held steady, closing at \$1,672.69 per dollar in the official market, reflecting no change from the previous rate. Meanwhile, in the parallel market, it ended the day at \$1,715 per dollar.

Global Commodity Market

Global oil prices climbed on Monday, with Brent Crude increasing by 0.44% to \$77.69 per barrel and West Texas Intermediate (WTI) rising by 0.51% to \$69.98 per barrel.
