

## NGX Extends Losses as ASI Dips 0.12% Amid Mixed Sectoral Performance, Naira Appreciates by 0.19% Against the Dollar in the Official Market ....

On Wednesday, the local bourse extended its negative trend from the previous session, as the All-Share Index declined by 0.12% to 105,800.85 points. This downturn also resulted in a 0.12% drop in market capitalization to ₦66.5 trillion, wiping out ₦81.29 billion from investors' portfolios. Despite the overall decline, market sentiment was mixed, buoyed by sectoral gains in Insurance (+0.87%), Oil & Gas (+0.04%), and Industrial Goods (+0.01%). In contrast, the Banking and Consumer Goods sectors fell by 1.46% and 1.98%, respectively, while the Commodity sector remained flat. Market breadth was positive, with 39 gainers outpacing 25 decliners. Top gainers included UPL, VITAFOAM, LIVESTOCK, CILEASING, and MCNICHOLS, while ETI, INTBREW, IKEJAHOTEL, CADBURY, and AUSTINLAZ led the losers' chart. Trading activity was subdued, as volume and value dropped by 46.39% and 63.85%, respectively, though the number of deals rose by 5.42%. Overall, 393 million shares valued at ₦12.76 billion were exchanged in 17,519 deals.

### Money Market

In the Nigerian money market, the Nigerian Interbank Offered Rate (NIBOR) declined across most tenors, except for the overnight rate, which rose by 0.04% to 26.79%. Meanwhile, money market indicators were mixed, with the Open Repo Rate unchanged at 26.50% and the Overnight Lending Rate falling by 0.12% to 26.83%.

The Nigerian Interbank Treasury Bills True Yield (NITTY) declined across most maturities, with the average yield on Treasury bills dropping by 0.04 percentage points to 20.73%.

### Bond Market

Sentiment in the secondary market for FGN bonds was bearish, as the average yield rose by 0.03 percentage points to 19.05%.

Bearish sentiment prevailed in Nigeria's sovereign Eurobond market, driven by widespread investor sell-offs across the curve, with the Mar-2029 issuance facing the most pressure. Consequently, the average yield surged by 35 basis points to 10.57%.

### Foreign Exchange Market


In the foreign exchange market, the Naira appreciated by 0.19% in the official window, closing at ₦1,596.69 per dollar. Similarly, the Naira ended the day at ₦1,595 per dollar in the parallel market.






