



Investors Price Nigerian Stocks Higher in Broad-based Sectoral Gains; ASI Up 0.62%, NIBOR Rises Across All Tenors Indicating Tight Liquidity Conditions in the System

The NGX opened the trading week on a strong note, as the All-Share Index rose by 0.62% to close at 106,698.50 points. Market capitalization followed suit, increasing by 0.62% to ₦67.06 trillion, adding approximately ₦412.3 billion to investors' wealth. Sectoral performance was largely positive: the Insurance, Consumer Goods, Oil & Gas, Industrial Goods, and Commodity sectors advanced by 2.69%, 2.90%, 2.58%, 0.07%, and 1.59%, respectively, while the Banking sector declined by 1.62%. Market breadth was positive, with 35 gainers outpacing 29 decliners. Top gainers included BETAGLAS (+9.97%), TIP (+9.90%), CADBURY (+9.87%), CAVERTON (+9.77%), and MULTIVERSE (+9.45%), while ETI (-9.62%), MEYER (-6.70%), CUSTODIAN (-4.72%), MBENEFITS (-4.49%), and ACCESSCORP (-3.88%) led the laggards. Trading activity remained robust, with the number of deals, volume, and value traded rising by 1.33%, 0.66%, and 26.61%, respectively. Overall, ₦18.93 billion worth of transactions were recorded across 18,612 deals involving 569.04 million units.

Money Market

In the Nigerian money market, the Nigerian Interbank Offered Rate (NIBOR) rose across all tenors, indicating tight liquidity conditions in the banking system. Meanwhile, key money market indicators were mixed, with the Open Repo Rate remaining steady at 26.50%, while the Overnight Lending Rate rose by 0.13% to 26.96%.

The Nigerian Interbank Treasury Bills True Yield (NITTY) curve recorded upward shifts across all maturities; nonetheless, the average yield on Treasury bills declined by 2 basis points to 21.03%.

Bond Market

Investor sentiment in the secondary market for FGN bonds remained positive, resulting in a marginal 1 basis point decline in average yields to 19.03%, indicating sustained demand for government securities under stable market conditions.

Investor demand strongly influenced Nigeria's sovereign Eurobond market, driving bullish sentiment and pushing yields lower across the curve. The Nov-2027 issuance saw the most significant impact, causing the average yield to drop by 2 basis points to 10.60%.

Foreign Exchange Market

In the foreign exchange market, the Naira depreciated by 0.19% in the official window, closing at ₦1,602.18 per dollar. Similarly, the Naira ended the day at ₦1,603 per dollar in the parallel market.






