**Bulls Bounce Back, Lifting ASI by 0.50% Amid Fresh Optimism, NIBOR Rises Across all Maturities....**

## Equities Market Summary

The Nigerian equities market reversed its recent bearish trend at the close of Wednesday's session, as the NGX All-Share Index (ASI) advanced by 0.50% to settle at 120,339.90 points. This uptick added approximately ₦379 billion to investors' wealth, pushing the total market capitalization to ₦76.18 trillion and lifting the year-to-date return to 16.92%. Investor sentiment remained largely positive, reflected in a strong market breadth—61 stocks closed in the green compared to 15 decliners. Top gainers included C&I Leasing, Ellah Lakes, NSL Tech, Smurfit, and Thomas Wyatt, each posting the maximum 10% daily gain. On the flip side, Deap Capital, John Holt, Dangote Sugar, Universal Insurance, and Oando topped the losers' chart. Sectoral performance was broadly positive. The Banking (+0.19%), Insurance (+0.76%), Consumer Goods (+1.78%), and Industrial Goods (+0.52%) indices all recorded gains on the back of renewed buying interest. However, the Oil & Gas index closed in the red, down 0.45%, due to profit-taking in select counters. Market activity remained robust, although key metrics showed slight declines. A total of 1.05 billion shares valued at ₦21.17 billion were exchanged in 21,964 deals, representing drops of 99.10% in volume, 7.95% in value, and 1.94% in the number of deals compared to the previous session.

## Money Market

The Nigerian Interbank Offered Rate (NIBOR) recorded an upward trend across all maturities, reflecting tightening liquidity conditions in the financial system. In response, money market rates exhibited mixed movements — the Open Repo rate remained unchanged at 26.50%, while the Overnight Rate edged up by 4 basis points to close at 27.00%.

The Nigerian Treasury Bills (NITTY) curve displayed a mixed performance across all maturities, reflecting divergent yield movements in the short- and medium-term segments. Despite this variability, the secondary market maintained a bullish tone, with the average yield declining by 20 basis points to settle at 19.85%.

## Bond Market

The FGN bond market closed slightly positive, as yields declined across key maturities, causing the average yield to fall by 30 basis points to 17.96%.

The Nigerian Eurobond market closed on a bearish note, driven by strong investor sell-offs across the curve, with the NOV-2027, FEB-2032, and SEP-2051 instruments attracting the most trading activity. As a result, average yields rose by 8 basis points to settle at 8.54%.


## Foreign Exchange Market

At the Nigerian Autonomous Foreign Exchange Market (NAFEM), the naira appreciated by 0.22% to close at ₦1,526 per US dollar, while in the parallel market, it ended at ₦1,565 per dollar.
