

Bulls Charge Ahead on Strong Rally with N1.74tn Gains, ASI Up 2.03%, Naira Appreciates Against the Dollar at the Official Market....

Equities Market Summary

The Nigerian equities market sustained its bullish momentum this week, as the NGX All-Share Index (ASI) climbed 2.03% to close at 137,912.87 points, lifting the year-to-date (YTD) return to 33.99%. This performance reflects sustained investor optimism and renewed confidence in market fundamentals. Market capitalisation rose by ₦1.74 trillion to ₦87.19 trillion, supported by resilient liquidity and persistent appetite for risk assets. Market breadth was positive, with 51 gainers versus 25 losers, driven by a blend of bargain hunting and selective profit-taking. Notable gainers included Berger, HMCALL, LearnAfrica, ThomasWY, and EllahLakes, which advanced by 10% each—except EllahLakes, which gained 9.99%. Meanwhile, top laggards were AbbeyBDS (-10.00%), NNFM (-10.00%), Vitafoam (-9.96%), IMG (-9.93%), and IntBrew (-7.10%). Sectoral performance was broadly upbeat, with gains across the board: Banking (+2.34%), Insurance (+1.93%), Consumer Goods (+2.78%), Oil & Gas (+2.46%), Industrial Goods (+4.10%), and Commodities (+1.62%). Trading activity also strengthened. Total volume and value traded rose by 18.25% and 31.84%, respectively, despite a 24.63% dip in the number of deals. Overall, 940.8 million shares valued at ₦30.63 billion exchanged hands across 28,358 deals.

Money Market

Interbank rates (NIBOR) advanced across most tenors, except for the overnight rate, which dipped by 2bps to 26.88%, reflecting improved system liquidity. In the money market, rates were mixed as the Open Repo Rate (OPR) held steady at 26.50%, while the Overnight (O/N) rate declined slightly by 4bps to 26.96%.

The Nigerian Treasury Bills (NITTY) curve witnessed yield increases across most maturities, reflecting a shift in investor sentiment. Despite the rise in yields, secondary market activity improved, with sell-side pressures driving the average yield up by 2 basis points to 17.66%

Bond Market

The FGN bond market closed mildly positive, as a mixed yield performance across key maturities drove the average yield down by 1 basis point to 16.21%, indicating moderate investor demand.

The Nigerian Eurobond market closed mixed, as uneven investor demand across the curve led to a 1bp drop in the average yield to 8.30%.

Foreign Exchange Market

At the Nigerian Autonomous Foreign Exchange Market (NAFEM), the naira appreciated marginally to close at ₦1,534 per US dollar, while in the parallel market, it ended at ₦1,540 per dollar.




