

Bulls Lose steam as Equities Market Dips 0.36% amid Profit Booking, Dollar Declines at Both NAFEM and Parallel Market....

Equities Market Summary

On Wednesday, the Nigerian stock market experienced a downturn, with the NGX All-Share Index (ASI) declining by 0.36% to close at 141,248.76 points, reducing the year-to-date return to 37.23%. Total market capitalization contracted by \$\frac{1}{324.34}\$ billion to \$\frac{1}{389.37}\$ trillion. Market sentiment remained subdued, evidenced by a negative breadth with 16 stocks advancing compared to 40 declining. Standout performers included DEAPCAP, LEGENDINT, HONYFLOUR, TANTALIZER, and AFRIPRUD, while LASACO, RTBRISCOE, ABCTRANS, NGXGROUP, and MBENEFIT were among the notable underperformers. Sectoral performance closed in a mix, with declines in Banking (-0.76%), Insurance (-3.42%), and Consumer Goods (-0.86%) sectors. The Oil & Gas sector, however, posted a modest gain of 0.18%, while the Industrial and Commodity sectors remained flat. Trading activity presented a mixed picture: the number of deals fell slightly by 0.52% to 28,695, while trading volume and value surged by 12.87% to 682.89 million units and 72.32% to \$\frac{1}{322.22}\$ billion, respectively.

Money Market

Interbank rates (NIBOR) sustained their upward trend across most maturities today, with the Overnight rate rising by 0.08%, and the 3-month and 6-month rates increasing by 0.21% and 0.25%, respectively, while the 1-month tenor remained steady at 27.58%. This uptick is largely attributed to a liquidity squeeze stemming from the Debt Management Office's (DMO) settlement of FGN bonds from Monday's auction. Money market rates showed varied performance: the Open Repo Rate (OPR) held steady at 26.50%, whereas the Overnight rate dipped slightly by 8 basis points to 26.88%.

The Nigerian Interbank Treasury Bills True Yield (NITTY) exhibited mixed performance, with yields on the 3-month and 12-month tenors rising by 7 basis points and 11 basis points, respectively. The 6-month tenor declined by 22 basis points, while the 1-month tenor remained unchanged at 16.21%. The average yield for NT-Bills increased by 14 basis points to 18.51%, reflecting persistent weak and negative investor sentiment in the secondary market.

Bond Market

The FGN bond market closed in a bearish note on Wednesday, this is driven by the intense sell-offs at the APR-2029, MAY-2029, NOV-2028, and NOV-2029. Thus, average market yield moved up by 3bps to close at 16.92% from the previous session.

The Nigerian Eurobond market concluded on a positive note, with the average yield declining by 4 basis points to 7.96%, indicating robust buying interest and optimistic investor sentiment.

Foreign Exchange Market

At the Nigerian Autonomous Foreign Exchange Market (NAFEM), the naira depreciated by 4% to \(\pm\)1,537 per US dollar, driven by unabating dollar demand. Similarly, in the parallel market, the naira also appreciated to close at \(\pm\)1,542 per dollar.






