

## Cowry Daily Market Insight 03 October 2019

NSE ASI Wanes by 84bps Amid Sustained Profit Taking Activities on Consumer Goods Stocks; NIBOR Dips on Renewed Liquidity Strain...

The Nigerian equities market journeyed further into the negative territory by 0.84% as investors were bearish on most consumer goods stocks, even as the Bourse registered 18 gainers as against 12 lagers at the close of trade today. Hence, the year to date performance of the ASI slid further into the red zone, 13.82% from 13.09%. Symbols such as NESTLE, UACN, GUINNESS, HONYFLOUR and OANDO plummeted by 9.99%, 3.57%, 3.24%, 1.00% and 1.60% respectively. Meanwhile, the total volume of equities traded plummeted by 9.67% to 175.78 million units while the total value fell by 16.18% to N2.57 billion. Elsewhere, NIBOR rose across tenure buckets amid renewed liquidity squeeze; however, NITTY dipped for most maturities tracked amid sustained bullish activity in the secondary treasury bills market. In the bonds market, the values of OTC FGN papers were flattish for most maturities tracked; however, FGN Eurobond values contracted across maturities tracked amid sustained sell-offs in the international bond market.
