



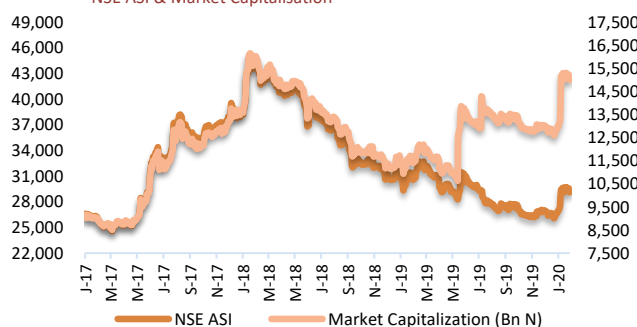

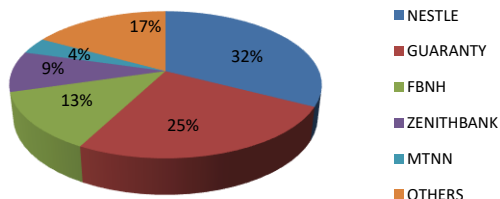
The Local Bourse Index Falls Marginally by 0.01% on Renewed Sell Pressure; NIBOR Declines for Most Tenor Buckets amid Sustained Liquidity Ease.....

The domestic equities market All Share Index (ASI) fell marginally by 0.01% to settle at 22,920.41 points, to halt the bullish streak which trended for seven days. Also, the Exchange recorded 16 losers as against 14 gainers at the close of trade. Hence, the year to date loss of the NSE ASI rose to 14.61%. Banking stocks such as ZENITHBANK, GUARANTY, ACCESS moderated by 5.67%, 4.33% and 4.48% respectively as investors booked profit; hence the NSE banking index declined by 4.01%. On the flip side NSE Insurance, NSE Consumer goods and NSE Industrial appreciated by 1.11%, 1.19% and 4.80% respectively. Meanwhile, the volume and value of shares traded rose by 49.15% and 61.20% to 0.34 billion units and 4.2 billion respectively. Elsewhere, NIBOR and NITTY declined for most tenor buckets amid sustained liquidity ease. In the OTC bonds market, the values of FGN bonds were flattish for most maturities tracked; also, FGN Eurobond declined for all maturities tracked amid bearish activity.
