





Domestic Equities Market Index Rises Marginally by 0.07% on Sustained Bullish Activity; NIBOR Rises for Most Tenor Buckets amid Sustained Liquidity Strain.....

The NSE All Share Index (ASI) rose marginally by 0.07% to close at 22,616.28 points on sustained bullish activity despite the Exchange printing 8 gainers as against 14 losers at the close of trade. Hence, the year to date loss of the NSE ASI moderated to 15.74%. Investors' buy interest in counters such as MTN, GUARANTY, OANDO and ZENITH advanced their respective share prices by 0.87%, 0.70%, 0.09% and 0.15%. Similarly, only the NSE banking and NSE oil/gas indices rose by 1.12% and 0.39% respectively. However, the NSE Insurance, NSE consumer goods and NSE Industrial indices declined by 0.25%, 1.90% and 0.04% respectively. Meanwhile, the volume and value of shares traded declined by 48.91% and 40.35% to 0.10 billion units and 1.3 billion. Elsewhere, NIBOR rose for most tenor buckets amid sustained liquidity strain; however, NITTY declined for most maturities. In the OTC bonds market, the values of FGN bonds rose for most maturities tracked; however, FGN Eurobond declined for all maturities tracked.
