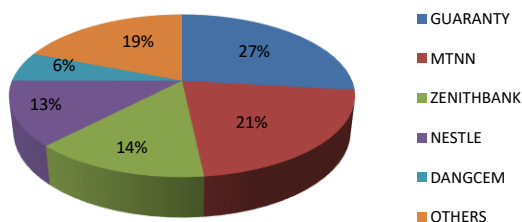
Local Equities Market Rises by 3.12% on Sustained Bargain Hunting; NIBOR Declines for All Tenor Buckets amid Sustained Liquidity Ease....

The Local Bourse All Share Index (ASI) advanced by 3.12% even as the Exchange recorded 29 gainers as against 7 losers at the close of trade. Hence, the year to date loss of the NSE ASI plunged to 11.29%. Investors' patronage on Bellwether stocks such as NESTLE, DANGCEM, MTNN, OANDO, and ZENITHBANK lifted their respective share prices by 5.96%, 10%, 3.45%, 6.77% and 3.48%. Similarly, the NSE Banking, NSE Consumer goods, NSE Oil & Gas and NSE Industrial appreciated by 2.42%, 2.42%, 0.73% and 1.56% respectively. Meanwhile, market activity was upbeat as the volume and value of stocks traded rose by 38.15% and 77.45% to 0.34 billion units and N4.25 billion respectively. Elsewhere, NIBOR declined for all tenor buckets amid sustained liquidity ease; also, NITTY moderated for most maturities tracked amid demand pressure. In the OTC bonds market, the values of FGN bonds appreciated for most maturities tracked amid bullish activity; also, FGN Eurobond rose for most maturities tracked on sustained bullish activity.
