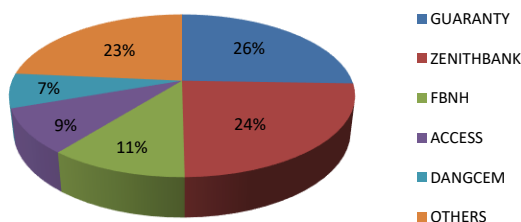
Local Equities Market Appreciates by 1.40% on Sustained Bargain Hunting; NIBOR Rises for All Tenor Buckets amid Renewed Liquidity Strain....

The Local Bourse All Share Index (ASI) appreciated by 1.40% even as the Exchange recorded 35 gainers as against 4 losers at the close of trade. Hence, the year to date loss of the NSE ASI moderated to 10.05%. Banking stocks were the toast of investors as ACCESS, ZENITHBANK, GUARANTY and UBA rose by 0.77%, 6.40%, 9.29% and 3.28% respectively. Similarly, all the sub-sector gauges tracked closed in positive territory; the NSE Banking, NSE Insurance, NSE Consumer goods, NSE Oil & Gas and NSE Industrial rose by 5.32%, 3.66%, 1.98%, 1.27% and 0.64% respectively. Meanwhile, the volume of stocks traded rose by 23.60% to 0.42 billion units; however, the value of stocks traded dipped by 3.53% to 4.1 billion. Elsewhere, NIBOR rose for all tenor buckets amid renewed liquidity strain; also, NITTY rose for most maturities tracked amid bearish activity. In the OTC bonds market, the values of FGN bonds were flattish for most maturities tracked; however, FGN Eurobond rose for most maturities tracked on sustained bullish
